

Support Fees

The Sacramento Region Community Foundation offers a variety of philanthropic funds to help donors achieve a wide range of charitable goals. Support fees help to cover our operations. Importantly, they are also reinvested in the community through grantmaking and programs — attending to critical regional issues, improving local lives, and multiplying the impact of our fundholders' giving. **Our shared commitment to the region is what sets us apart from other institutions.**

Fees depend on the type and size of fund. For most fund types, a minimum support fee of \$250 will be applied. Often, fee rates are annual and paid directly from the fund balance on a monthly basis. We maintain a tiered support fee structure for gifts over \$1 million; if the balance of the fund changes over time, the support fee percentage will be adjusted, if applicable. *For instance, on the first \$1 million of an expendable Donor Advised Fund, the Foundation assesses a 2% support fee. On the next \$1 million, the Foundation charges 1.75%, and so on.*

Scholarship Funds

Services covered by fees include fund establishment, gift acknowledgement, investment management, grants administration, and individualized services, such as research on nonprofits and special requests. Other direct costs (such as appraisal or legal fees) attributable to the activities of a fund are passed directly to the fund. Stated fees decrease as balances grow and can vary depending on services requested. Under special circumstances, expendable fund fees may be assessed on gift activity or grant activity. The Board may review and adjust these fees at its discretion, no more than once per year, with 45 days' notice to fundholders.
