We offer a range of services and products that can be tailored to your business and make it easy for your company to support the causes you, your team, and your customers care about — locally and across the country. You can use cash, stock, or other assets to establish a fund for \$10,000 and qualify for an immediate tax deduction.

Key Benefits

Easy and Flexible: Depending on the fund type you create — a Donor Advised Fund, Scholarship, or Field of Interest Fund — you or a staff member can initiate grants to support selected causes, or you can empower our staff to conduct grantmaking on your behalf. Your company can contribute gifts to your fund when it is financially advantageous and sustain your giving over time, using our secure fund management portal to track your fund's activities.

Efficient and Impactful: Your staff can focus their time and energy on operating a successful business while we handle the administrative tasks of philanthropy by investing the fund's assets, distributing grants on your company's behalf, providing statements and tax reporting for the fund — all for a nominal Support Fee. The annual Support Fee is the greater of \$250 or 2% of the fund's balance for expendable funds and 1.5% for endowed funds, which we re-invest into the community through our strategic grantmaking and impact programs.

Employee-Friendly: Creating a culture of philanthropy at your business can foster a sense of community pride and strengthen your employee engagement. We can help you promote and launch a matching gifts program, create an employee advisory committee to guide your company's giving, and promote the impact of your team's generosity, so your fund helps achieve your business goals while making a positive difference in our community.
