## GETTING STARTED IS EASY

A Donor Advised Fund is a personalized fund that makes it easy for you to support the causes and organizations you care about locally or across the country. You can use cash, stock, or other assets approved by our board to create a named fund, qualify for an immediate income tax deduction, and when it's convenient for you, choose the charities you want to support. You can open your Donor Advised Fund for as little as \$10,000.

## IMMEDIATE IMPACT OR ENDURING IMPACT

You can choose to open an *expendable* fund, allowing you to decide when and how much to give as long as you maintain a minimum balance of \$500. You can also create an *endowed* fund, meaning that the funds are invested in perpetuity and a portion of the balance can be granted out each year.

Add to your fund anytime, and have access to your fund and grant history 7 days a week, 24 hours a day. The Foundation accepts gifts of many types of assets, including stock and real property. Our staff will work closely with your financial advisor to help facilitate gifts of all types.

### PERSONALIZED SERVICE

Your fund reflects the causes and organizations you care about in this region and beyond. We're here to offer individualized service and strategies to help you carry out your goals and suggest ways to increase your impact through exclusive donor communications, learning sessions and special events.

### EFFICIENCY

Foundation staff handles all the administrative tasks of achieving your philanthropic goals— from investment options and quarterly statements to advising you on charitable giving – all for a nominal support fee to support our work on behalf of the community. The annual Support Fee is the greater of \$250 or 2% of the fund's balance for *expendable* funds and 1.5% for *endowed* funds.
